TERMS & CONDITIONS FOR PROVIDING AND FIXING OF PARKING SHED CONSISTING OF CGI SHEET INCLUDING ALL ACCESSORIES AT UNIVERSITY OF LAKKI MARWAT, KHYBER PAKHTUNKHWA, PAKISTAN.

1. Before submitting the bids interested contractors must visit the site at ULM, to examine the site of works/its surroundings and obtain for themselves on their own responsibilities all information's that may be necessary for preparing the bid and entering into a contract for construction of the works. All cost in this respect shall be at the bidder own expense. The interested contractor may have carried out such work in last 5 years.
2. Tender must contain a call deposit 2% of bid as earnest money in the name of treasurer ULM Lakki Marwat. Tender without earnest money will not be entertained.
3. Work will be awarded on the basis of above/below on MRS 2020 Govt. of Khyber Pakhtunkhwa.
4. The bid should be free from cutting and over writing, first two 02 digits after decimal will be considered for evaluation.
5. Any cutting/overwriting and disfiguration in rates if found, bid will be rejected.
6. 10% security will be deducted from each running bill which will be released after maintenance period of one year.
7. The contractor/bidders, who quote their bids/rates below on MRS 2020, shall submit an additional security as per prevailing KPPRA rules/ rules of Govt of Pakistan/Khyber Pakhtunkhwa. In case of bid/rate quoted by the bidder more than 10% below engineer estimate, the additional bid security shall be sought from the successful bidder only to the extent of bid more than 10% below the engineering estimate in the form of percentage. The amount of additional security shall be equal to the impact of financial difference occurring in the quoted rates beyond the 10% below engineer estimate and the successful bidder shall be bound to produce the additional security within three working days from the issuance of LOA and failing which the procuring entity shall forfeit the bid security of successful bidder and may also initiate legal proceeding against the bidder who repudiated the contract under KPPRA procurement rules
8. Incomplete/postal/telegraphic/late and conditional tenders will not be considered.
9. The pre-bid meeting will be held in the University of Lakki Marwat on dated 18-09-2020 at 11:00AM. Quotation must reach the office of the undersigned up to 25-09-2020 upto 11:30AM which will be opened on the same day at 12:00PM in the presence of members' technical committee and contractors or their representatives.
10. Income tax will be deducted as per Govt of Pakistan rules.
11. No escalation will be entertained of any item on these works.
12. The contractor will arrange the water, electricity and any other facilities required at his own for execution of works.
13. The authority reserves the right to accept/reject some or all bidders as per rules.
14. Govt of Pakistan and ULM rules will be applicable.
15. Apart from above mentioned conditions any other condition imposed by Govt from time to time will be applicable.
16. The contractor will present himself or authorized representative for submission of application & the work will be executed by the contractor. The approved contractor cannot sub-let any work without the prior written permission of concerned authority ULM.
17. The material must be verified by concerned official prior to start of works.
18. The contractor must appoint a well qualified and experienced engineer/foreman working at the site.
19. The contractor will make all arrangements at site including accommodation/safety/security etc.
20. Contractor will submit the bill with the concerned department of ULM.
21. The contractor will have to follow the instructions/directions of the official in charge to carry out the work and changes can be occurred as per site requirements. The official in charge will decide the matter involving any technical disputes.
22. The contractor will keep a site office where staff of contractor will readily be available.
23. In case of any major dispute, the Vice chancellor will take the final decision whose decision cannot be challenged in court.
24. In case of more than 30 days delay in start of work, the ULM can terminate the agreement.
25. In case of bids become tie (two or more bidders offering same rates/cost) the award of the contract shall be decided through a free toss which shall be binding and final on the bidders.
26. No mobilization advance will be granted.
27. The bidder should proved affidavit that their firm has not been blacklisted from any Govt department.
28. The payment will be subjected to approval of competent official, authority and availability of funds.
