## INVITATION OF BIDS

### CONSTRUCTION OF ADMINISTRATION BLOCK & ACADEMIC BLOCK (PACKAGE-I) AT UNIVERSITY OF LAKKI MARWAT.

1. University of Lakki Marwat, Lakki Marwat invites sealed bids from reputed firms/contractors for “Construction of Administration Block & Academic Block (Package-I) at University of Lakki Marwat, Lakki Marwat” having adequate experience in carrying out projects of similar nature, valid registration with PEC/KPPRA in minimum Category C-3 with relevant field of specialization valid Income Tax & Sales Tax registration and who are on Active Tax Payers’ List at the time of Submission of Bids.
2. Bidders may purchase the Bidding Document up to May 7, 2021 during working hours from the office of Deputy Director Works, University of Lakki Marwat, upon payment of non-refundable fee of Rs.7,000/-Rupees (Seven Thousand only) in shape of CDR/ Bank draft in favor of Treasurer, University of Lakki Marwat, Lakki Marwat.
3. Under Single Stage – Two Envelope Bidding Procedure, one envelope containing Technical information of Bid shall be clearly marked “Technical Bid” and the second envelope containing the Bid Price shall be clearly marked “Price Bid.”
4. Pre-bid meeting will be held on May 03, 2021 at 11:00 AM in the office of the Deputy Director Works, University of Lakki Marwat.
5. The envelop of “Price Bid” shall be accompanied by Bid Security in the amount of minimum of 2% of Estimated Price without indicating the figure in the letter, and in the form of Deposit at Call or Bank Guarantee issued by a scheduled bank in Pakistan in favour of Treasurer, University of Lakki Marwat, Lakki Marwat.
6. The Bidder shall provide an affidavit along with Technical Bid stating that requisite Bid Security is sealed with the envelope of Price Bid. Otherwise, Technical Proposal will be considered as non-responsive.
7. Bidding Documents shall be issued to the original contractors/firms/companies or their/his authorized agent (through a stamped paper of value Rs. 30) on the production of original/attested copies of Registration/renewal fee receipt for the Year 2020-2021 or valid license from the PEC in the relevant category.
8. In case of bid/rate quoted by the bidder more than 10% below engineer estimate, the additional bid security shall be sought from the successful bidder only to the extent of bid more than 10% below the engineer estimate in the form of percentage. The amount of additional bid security shall be equal to the impact of financial difference occurring in the quoted rates beyond 10% below engineer estimate and will be dealt with Khyber Pakhtunkhwa Notification No. KPPRA/M&E/Estt/1-17/2019-20 dated June 12, 2020.
9. Envelopes of “Technical Bid” and “Price Bid” shall be submitted at the address of Deputy Director Works by 10th May at 11:00 AM through Courier. The envelope containing Technical Bid shall be opened on the same day at 11:30 AM in the presence of Bidder’s representatives who choose to be present. Bids received after the prescribed time and date shall be rejected.
10. Bidders will be Technically Qualified on the basis of information provided with the Bids, as per the Criteria prescribed in the Bidding Documents.
11. Envelopes of Price Bids of only “Technically Qualifying Bidders” will be opened in the presence of Bidder’s representatives who choose to attend at the date and time to be determined and communicated later.
12. Envelopes of “Price Bid” of Bidders who fail to qualify shall be returned to them unopened.
13. University of Lakki Marwat, however reserves the right to reject all bids at any time prior to acceptance of a bid as per Clause 47 of the Khyber Pakhtunkhwa Procurement Rules, 2014 and grounds of rejection will be conveyed to the bidders upon their request.
